MISUSE OF DRUGS (CANNABIS) (AMENDMENT) REGULATIONS 2023

Approved by Tynwald:

Coming into operation: in accordance with regulation 2

The Isle of Man Gambling Supervision Commission, after consultation with the Advisory Council on the Misuse of Drugs, makes the following Regulations under sections 30 and 31 of the Misuse of Drugs Act 1976.

1 Title

These Regulations are the Misuse of Drugs (Cannabis) (Amendment) Regulations 2023.

2 Commencement

If approved by Tynwald, these Regulations come into operation on the day after they are approved¹.

3 Misuse of Drugs (Cannabis) Regulations 2020 amended

- (1) The Misuse of Drugs (Cannabis) Regulations 2020² are amended as follows.
- (2) In the table in Schedule 2, in the entry for -
 - (a) Class 1, Licence for low-THC cultivation without use, Annual fee (£), for "500" substitute 525 52;
 - (b) Class 2, Licence for low-THC cannabis cultivation with use, Annual fee (\pounds) , for "10,000" substitute **41**0,500 **52**;
 - (c) Class 3, Licence for high-THC cannabis cultivation, Annual fee (£), for "45,000" substitute ⁴47,250 ₺;
 - (d) Class 4, Licence for cultivation of cannabis using male plants, Annual fee (£), for "20,000" substitute 21,000;

- (e) Class 5, Licence for transportation and storage, Annual fee (£), for "5,000" substitute 5,250 ;
- (f) Class 6, Licence for extraction, Annual fee (£), for "22,500" substitute 23,625;
- (g) Class 7, Licence for importing into the Isle of Man, Annual fee (£), for "10,000" substitute ™10,500 ;
- (h) Class 8, Licence for exporting from the Isle of Man, Annual fee (£), for "10,000" substitute ™10,500 ;
- (i) Class 9, Licence for manufacturing cannabis-derived products, Annual fee (£), for "22,500" substitute 23,625;
- (j) Class 10, Licence for operating a test laboratory, Annual fee (\pounds) , for "12,500" substitute **51**3,125 **52**.
- (3) In the table in Schedule 3, in the entry for -
 - (a) Class 1, Licence for low-THC cultivation without use, Annual fee (£), for "250" substitute 265 (5);
 - (b) Class 2, Licence for low-THC cannabis cultivation with use, Annual fee (£), for "5,000" substitute 5,250;
 - (c) Class 3, Licence for high-THC cannabis cultivation, Annual fee (£), for "35,000" substitute **™** 36,750 **№**;
 - (d) Class 4, Licence for cultivation of cannabis using male plants, Annual fee (£), for "12,000" substitute 12,600;
 - (e) Class 5, Licence for transportation and storage, Annual fee (£), for "2,500" substitute 2,625 ;
 - (f) Class 6, Licence for extraction, Annual fee (£), for "17,500" substitute \square 18,375 \square ;
 - (g) Class 7, Licence for importing into the Isle of Man, Annual fee (£), for "7,500" substitute **™**7,875 **№**;
 - (h) Class 8, Licence for exporting from the Isle of Man, Annual fee (£), for "7,500" substitute ™7,875 ;
 - (i) Class 9, Licence for manufacturing cannabis-derived products, Annual fee (£), for "15,000" substitute 15,750;
 - (j) Class 10, Licence for operating a test laboratory, Annual fee (\pounds) , for "8,000" substitute 38,400.
